## POST-HOLIDAY PARTY



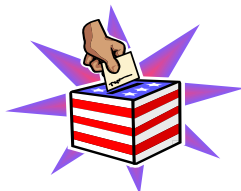

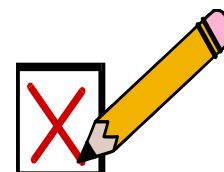
## OUR SCOTTISH RITE "ADVENTURE" *CONTINUES...*
